## ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of PISCES CHARTER INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of the corporation is PISCES CHARTER INC.

#### ARTICLE VII. INCORPORATOR


#### ARTICLE VIII. BYLAWS
