**Articles of Incorporation  
of  
Educational Symposia Acquisition Corp.**

**THE UNDERSIGNED**, acting as the sole Incorporator of Educational Symposia Acquisition Corp. ("Corporation") under the Florida Business Corporation Act, Chapter 607, Florida Statutes, as hereafter amended and modified (the "FBCA"), hereby adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I**

**Name**
