ARTICLE I - NAME

The name of this Corporation is MOFFIKKEY ENTERTAINMENT, INC..



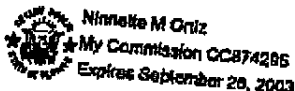
