ARTICLES OF INCORPORATION OF N G GENERAL REPRESENTATIONS, INC.

The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I.

<u>NAME</u>
