

ARTICLE X = INDEMNIFICATION


The corporation shall indemnify any officer or any former officer to the full extent permitted by law.



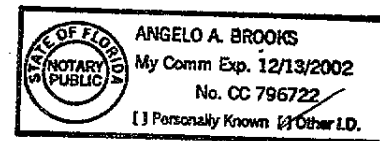


