**ARTICLE I - NAME**

The name of this Corporation is MAISON ENTERPRISES, INC.

**ARTICLE II - DURATION**

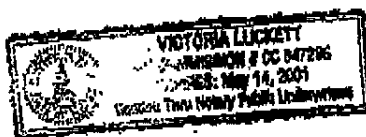
