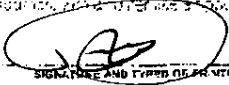

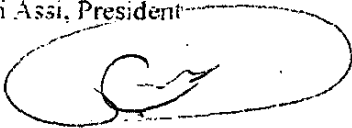
Please find enclosed the UBR Reports for 2002 and 2003 for Assi Auto Sales, Inc. and a check for \$300.00 for the fees for those two years.
