ARTICLES OF INCORPORATION

The undersigned, all of whom are duly licensed to practice Real Estate sales in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Professional Service Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Craig J Della Vedova, JR, P.A..

The period of its duration is perpetual.




ARTICLE EIGHT
