The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

## ARTICLES 1: NAME OF THE CORPORATION

The name of the corporation is Sister's Of Faith, Inc. hereinafter referred to as the "Corporation".

The period of duration of the Corporation shall be perpetual unless dissolved according to law.
