ARTICLE I

NAME

The name of this corporation is **PEGASUS SECURITY SERVICES, INC.**

ARTICLE II

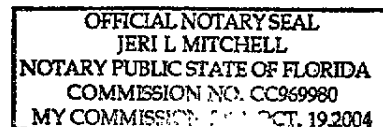
