ARTICLES OF INCORPORATION

A FLORIDA CORPORATION

The undersigned subscribes to Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

Article I

The name of the Corporation is Creative Illusions by Jeoffrey, Inc.

Article II

The Corporation is to exist perpetually unless dissolved in accordance with the Laws of the State of Florida.

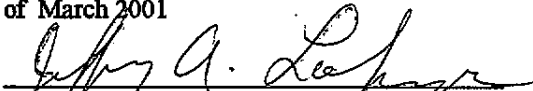

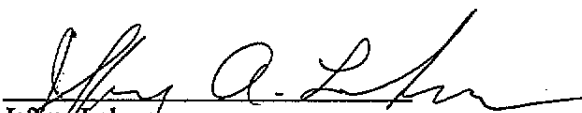
