#### ARTICLES OF INCORPORATION

The undersigned hereby establishes the following for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

# ARTICLE I Name of Corporation

The name of this Corporation shall be AMERICLEAN OF PALM BEACH COUNTY, INC. (the "Corporation").

# ARTICLE II Mailing Address and Principal Place of Business

The mailing address and principal place of business of the Corporation is 3789 Miramontes Circle, Wellington, Florida, 33414.

## ARTICLE III Purpose

This Corporation is organized for the following purposes:


