# ARTICLES OF INCORPORATION OF WALDEN INSTITUTE, INC.

The undersigned, acting as Incorporator of Walden Institute, Inc., pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### **ARTICLE I**
