ARTICLES OF INCORPORATION
OF

ARTICLE I: CORPORATE NAME

The name of this Corporation is **Pier Pressure Works, Inc.**, and its mailing address is, **15657 Waverly St. # 1, Clearwater, FL 33760**.

ARTICLE II: NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is **100** shares of common stock having par value of five **(\$1.00)** dollars.

ARTICLE IV: TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing upon the filing of these articles.

ARTICLE V:
REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The Registered Agent and the street address of the Initial Registered Office for this Corporation in the State of Florida shall be: **Daniel J. O'Mara, at 15657 Waverly St. # 1, Clearwater, FL 33760**. The board of directors from time to time may move the Registered Office to any address in the State of Florida.

ARTICLE VI: BOARD OF DIRECTORS

This Corporation shall have one director (s) initially. The number of directors may be increased or diminished from time to time by the Bylaws adopted by the stockholders, but shall never be less than one.


ARTICLE X: PRE-EMPTIVE RIGHTS


