#### ARTICLE I: CORPORATE NAME



The name of this Corporation is Pier Pressure Works, Inc., and its mailing address is, 15657 Waverly St. # 1, Clearwater, FL 33760.

#### ARTICLE II: NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.
