

ARTICLE ONE

The name of the corporation is NEW HORIZON FINANCIAL SERVICES, INC. The principal address of the corporation is: 3047 North Oakland Forest Drive, #102, Oakland Park, Florida 33309.

The aggregate number of shares which the corporation shall have authority to issue is 100, at \$1.00 par value.


ARTICLE FIVE
