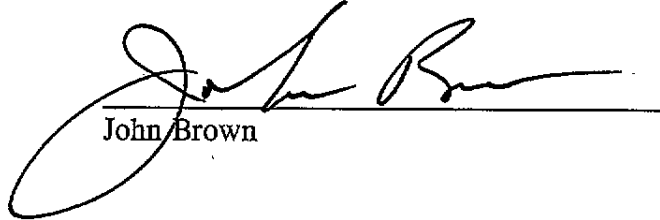
VI. DIRECTORS

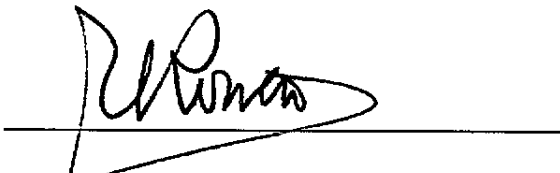

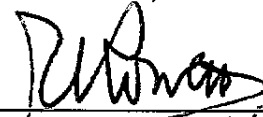
