ARTICLES OF INCORPORATION OF DOLLAR BILL SALOON INC. OF CAPE CORAL INC.

ARTICLE I NAME

The name of this Corporation shall be Dollar Bill Saloon Cafe. OF CAPE CORAL INC.

ARTICLE II COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department Of State.

ARTICLE III PURPOSE
