ARTICLES OF INCORPORATION
OF
COMMAIR SOUTHEAST ACQUISITION CORP.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

1. The name of the Corporation shall be: Commair Southeast Acquisition Corp.
2. The address of the principal office of the Corporation is: 7210 Anderson Road, Tampa, FL 33634, and the mailing address of the Corporation is: 7210 Anderson Road, Tampa, FL 33634.
3. The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution. The Corporation is authorized to issue 100,000 common shares.

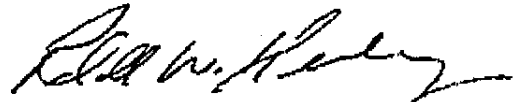
