ARTICLES OF INCORPORATION

ARTICLE I

Name and Principal Office

The name of this corporation is MANAGEMENT AND ADMINISTRATIVE SERVICES, INC. The principal place of business and mailing address of this corporation is 943 Southeast Ft. King Street, Ocala, FL 34471.

ARTICLE II

Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III

Purpose

This corporation is organized for the purpose of transacting any and all lawful business, except that this corporation is not authorized to engage in the business of banking, insurance or engineering.

ARTICLE IV

Capital Stock

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is One Thousand Two Hundred (1200) Shares of common stock, with a par value of One (\$1.00) Dollar per share. The shares of the corporation are not to be divided into classes and the corporation is not authorized to issue shares in series.

ARTICLE V

Preemptive Rights

Every shareholder, upon the sale for cash of any authorized and unissued common stock of this corporation, shall have the right to purchase his/her prorata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI

Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 943 Southeast Ft. King Street, Ocala, FL 34471, and the name of the initial registered agent of this corporation at that address is MERRITT C. FORE, JR.

ARTICLE VII

Initial Board of Directors


