# ARTICLES OF INCORPORATION

The undersigned M. TED COOKE does hereby make, subscribe, acknowledge and files these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

# ARTICLE I

# NAME

The name of this corporation shall be WATERSIDE POOLS
OF TAMPA BAY, INC.

# ARTICLE II

### NATURE OF BUSINESS

The general nature of the business to be transacted is manufacturing and construction of in-ground pools and spas, and related services.

The corporation is organized for the purpose of transacting any and all other lawful business and is organized to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

### ARTICLE III

### CAPITAL STOCK

The capital stock of this corporation shall consist of Seven Thousand Five Hundred (7500) shares of common stock with no parvalue.
