ARTICLES OF INCORPORATION OF PREMIER SPORTS, INC.

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be PREMIER SPORTS, INC.

ARTICLE II DURATION

The term of existence of the corporation is perpetual.

ARTICLE III PURPOSE

The purposes of the corporation are:

- (a) To engage in the business of the establishment and operation of a sports complex, including, but not limited to, outdoor sports and athletic playing fields and facilities, and indoor sports facilities including but not limited to, sports playing areas, locker rooms, concession areas and viewing areas, and to engage in any other related activities.
- (b) To engage in and to transact any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.
