- The period of its duration is perpetual. 2.

- Any shareholder, or the corporation itself as provided by these by laws, shall have the pre-emptive right to purchase shares of any class of capital stock of the corporation, including treasury shares if the same or greater consideration is paid for such treasury shares as was incurred by the corporation.
