The undersigned subscribers to these Articles of Incorporation, hereby form a corporation under the Florida General Corporation Act.

ARTICLE I

The name of the Corporation is: **PNS BUSINESS INC.**

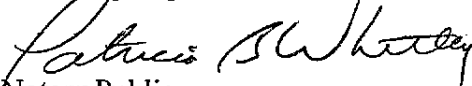
