ARTICLE I - NAME

The name of this corporation is: E-TextBooks, INC., with the principal place of business located at: 245 SE 1ST. STREET STE 430, MIAMI, FL. 33131.

ARTICLE II - PURPOSE

This corporation shall have perpetual existence and may engage in any and all lawful business under the laws of the United States and the State of Florida.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 100 shares of one dollar (\$1.00) par value common stock.


