ARTICLES OF INCORPORATION of CLOVERLEAF CAPITAL ADVISOR'S, INC.



THE UNDERSIGNED, acting as the sole incorporator of Cloverleaf Capital Advisor's, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation of Cloverleaf Capital Advisor's, Inc. for such corporation:

ARTICLE 1

Name and Address
