ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as the sole incorporator of **Cloverleaf Capital Advisor's, Inc.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation of **Cloverleaf Capital Advisor's, Inc.** for such corporation:

ARTICLE I

Name and Address

Action By Consent


The directors of this corporation may take action by written consent as provided by law.
