We, the undersigned, hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.,

ARTICLE I - Corporate Name

The name of the corporation shall be:

The corporation shall have perpetual existence.


ARTICLE IX


