ARTICLES OF INCORPORATION OF U.S. CAPTIAL ADVISORS, INC.

STATE OF THE PARTY OF THE PARTY

I, the undersigned, being of legal age, do hereby associate for the purpose of becoming a corporation under the laws of the State of Florida authorizing the formation of corporations.

ARTICLE I

The name of the corporation shall be: U.S. Capital Advisors, Inc.

ARTICLE II

The general nature of the business and the object and purposes proposed to be transacted and carried on are to engage in any and all activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows: 500 shares at \$1.00 par value.

ARTICLE IV

This corporation shall exist perpetually unless sooner dissolved according to the law and said corporation's existence shall commence on the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE V

ARTICLE VI

The number of directors of this corporation shall not be less than one (1) nor more than five (5). The corporation shall initially have one (1) director.

If the corporation is managed by directors, the exact number of directors shall be determined by the stockholders from time to time, but at no time shall there be less than one (1) director. At no time shall the corporation be managed by the stockholders unless there is at least one (1) stockholder.

ARTICLE VIII

Any restrictions imposed by the corporation on the sale or other disposition of its shares and on the transfer thereof must be noted conspicuously on each certificate representing shares of which the restriction applies.

The private property of the stockholders shall not be subject to the payment of the corporate debts in any extent whatever.
