Pursuant to the provisions of Section 607.1003 and 607.1006 of the Florida Statutes, CNL RESTAURANTS XX, INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:


1. The name of the Corporation is CNL RESTAURANTS XX, INC.
2. The original Articles of Incorporation for the Corporation were filed on March 29, 2001, and assigned document number P01000032463.
3. By written consent executed on July ~~26<sup>th</sup>~~<sup>21<sup>st</sup></sup>, 2001 by the sole Director and sole Shareholder of the Corporation, respectively, the sole Director and sole Shareholder have agreed that the Articles of Incorporation be amended to change the name of the Corporation to "RESTAURANT PROPERTIES XX, INC."
