

ARTICLES OF INCORPORATION

SECRETARIST MONES

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

<u> Article I - Name</u>

The name of this Corporation is GREG RUSSELL'S COMPLETE LAWN SERVICE, INC. The principal place of business of this Corporation shall be 217 Katherine Blvd., Palm Harbor, Florida 34684 or such other place as may be designated by the Board of Directors.

Article II - Capital Stock

The Corporation shall have the authority to issue 10,000 shares of common stock with a par value of \$1.00 per share.
