The number of shares the corporation is entitled to issue is 1,000 shares.

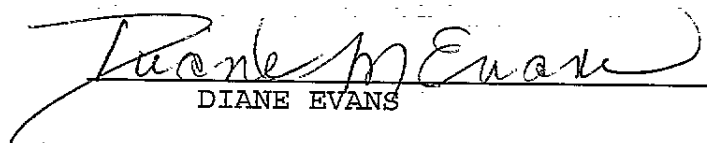

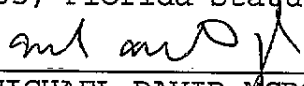
