**ARTICLE I - NAME**

The name of this Corporation is **INTERECONOMIA MIAMI, Inc.** and the address of the Corporation is 1236 S.W. 22 Avenue, Miami, Florida 33135

**ARTICLE II - DURATION**

This Corporation shall have a perpetual existence commencing on the date of filing.

**ARTICLE III - PURPOSE**

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

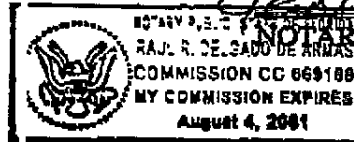
