NAME

**INDEMNIFICATION**

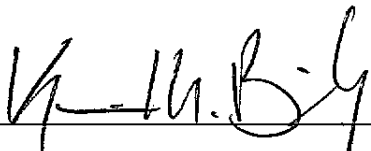
