ARTICLES OF INCORPORATION

OF

CHAP THE TENERS OF SHAPE OF SH The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Pierantonio, Inc.


