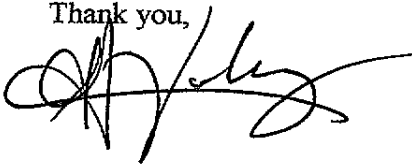

**ARTICLE OF INCORPORATION**

The undersigned, acting as incorporator of this corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopt the following Articles of Incorporation:

**ARTICLE I: NAME OF THE CORPORATION**

The name of the corporation is **AIRAYITI INC.**, herein after referred to as "corporation".

**ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office and mailing address of the Corporation is at **8034 NE 2<sup>ND</sup> AVE, MIAMI, FL 33138.**

**ARTICLE III: DURATION OF THE CORPORATION**

The period of duration of corporation shall be perpetual unless dissolved according to law.

**ARTICLE IV: PURPOSE OF THE CORPORATION**

The purposes for which the corporation is organized are to engage in any and all lawful business for which corporations may be incorporated in the State of Florida.

**ARTICLE V: AUTHORIZE SHARES**

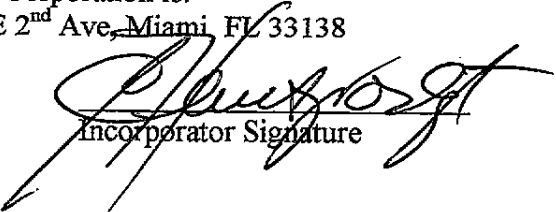
