BY-LAWS



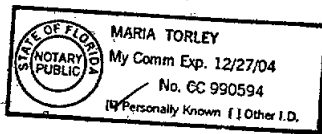
