ARTICLES OF INCORPORATION

OF

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation ("Corporation") is INDEPENDENT WIRELESS REPRESENTATIVES ALLIANCE, INC.


