ARTICLE I - Name

The name of this corporation is CTC Fiber, Inc.

ARTICLE II - Duration

This corporation shall have perpetual existence.

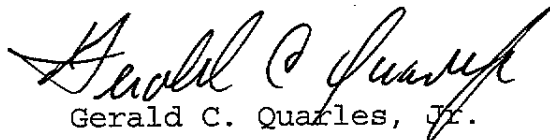
