# ARTICLES OF INCORPORATION

We, **THE UNDERSIGNED**, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation; liability, rights, privileges, and immunities of corporations for profit.

***ARTICLE XII, REGISTERED AGENT AND REGISTERED OFFICE.***


