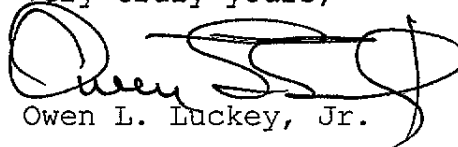

ARTICLE I

The name of this corporation is PIERCE BROTHERS LAND LEVELING, INC., a Florida corporation.

ARTICLE II

The corporation may transact all lawful business for which a corporation may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE III

The corporation is authorized to issue 100 shares of \$1.00 par value stock.

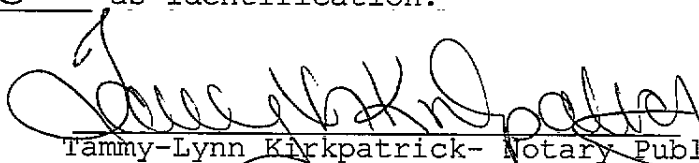

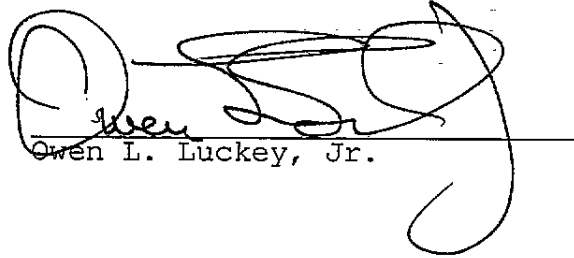
