

**ARTICLES OF INCORPORATION  
OF  
SUN HOME INSPECTIONS, INC.**

The undersigned incorporator hereby adopts the following articles of incorporation for the purpose of forming a FOR PROFIT corporation (the "corporation") under the Florida Law, pursuant to chapter 607 and 621 of the Florida Statutes ("chapters 607 and 621" ).

**ARTICLE 1  
Name**


**ARTICLE 9**
