WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State providing for the information, liability, rights, privileges and immunities of a corporation for profit.

**ARTICLE - I**

The name of the corporation shall be:

**PRUSA'S TILE & CONSTRUCTION SERVICES, INC.**

**ARTICLE - II**

The general nature and purpose of the business is to provide assistance to the public which are permitted under the laws of the United States and this State, to and including the installation of tile for residential and commercial property, renovation of construction of residential and commercial property, restoration of residential and commercial property, installation of equipment and construction materials to residential and commercial property, and any and all other business as it relates to the tile and construction services to residential and commercial property, and any and all other services which maybe permitted and can be provided to the public which are permitted under the laws of the State of Florida and the United States of America, to and including all foreign countries.

The maximum shares of stock that the corporation is authorized to have outstanding at any time are One Hundred (100) Shares of stock at no par value.

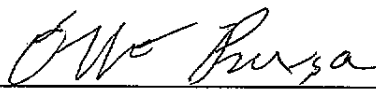
### **ARTICLE - VII**
