ARTICLES OF INCORPORATION

of

NEIL L. KRONICK, D.D.S., P.A.

ARTICLE I

CORPORATION NAME

The name of this Corporation is NEIL L. KRONICK, D.D.S., P.A.

ARTICLE II

PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida. The Practice of Dentistry.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock.

The common stock of the corporation shall have the following characteristics:

- (1) Par value shall be \$1.00 per share.
- (2) At all meetings of the stockholders, the common stockholders shall be entitled to cast one (1) vote for each share of common stock owned. That a common stockholder is interested in a matter shall not disqualify him from voting thereon.
- (3) Except as otherwise provided by law, the entire voting power for the election of directors and all other purposes shall be vested exclusively in

ARTICLE IV

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT

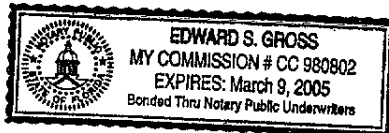
