To Whom It May Concern: On November 4th 2002 J&D Ventures was placed into administrative dissolution for lack of filing an annual report. Shortly after discovering this, we (J&D Ventures) contacted your department, and indicated that we had not received the required forms, and that being a new company, were not aware that we should have been looking for them.
