



ARTICLES OF INCORPORATION

OF

The undersigned hereby forms a corporation for profit under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be D. P. Plumbing, Inc. The address of the principal office of this corporation shall be 115 Juno Street, Jupiter, Florida 33458 and the mailing address of the corporation shall be the same.
