## ARTICLES OF INCORPORATION OF



#### CORNERSTONE BUSINESS SERVICES, INC.

The undersigned incorporator hereby forms a corporation under the laws of the State of Florida in compliance with Chapter 607.

#### **ARTICLE I: NAME**

The name of this corporation shall be CORNERSTONE BUSINESS SERVICES, INC.

#### **ARTICLE II: TERM OF EXISTENCE**

The duration of this corporation shall be perpetual or until dissolved in accordance with law.

#### **ARTICLE III: NATURE OF BUSINESS**
