The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopt the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name of the corporation is **CITIZEN MORTGAGE PROFESSIONALS, INC.**

**ARTICLE II**

**Principal Office**

The principal office and mailing address of the corporation shall be 4241 Baymeadows Road, Suite 6, Jacksonville, FL 32217.

**ARTICLE III**

**Duration**

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.
