ARTICLES OF INCORPORATION OF ENMARKE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act. Adopts the following articles of incorporation.

**ARTICLE ONE
NAME**

The name of the corporation is **ENMARKE, INC.**

The duration of the corporation is perpetual.

**ARTICLE FIVE
PURPOSE OF PURPOSES**

The general purposes for which the corporation is organized are:

1. To engage in the business of interior design for residential and commercial dwellings.
2. To engage in any other trade or business, which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.
3. To do such things as are incidental to the above or necessary or desirable in order to accomplish the above.

**ARTICLE SIX
CAPITALIZATION**

The aggregate number of shares, which the corporation is authorized to issue, is one thousand. Such shares shall be of a single class, and shall have no par value.

Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in Section 1361 (c) (2) (or its successor section) of Internal Revenue Code. In addition, no stock shall be issued or transferred to a nonresident alien.




