ARTICLES OF INCORPORATION
OF
ARBOR RIDGE TREE FARM, INC.

The undersigned Incorporator does hereby adopt the following Articles of Incorporation under Chapter 607 of the Florida Statutes, known as the Florida general Corporation Act:

ARTICLE I
NAME AND ADDRESS

The name of this corporation shall be ARBOR RIDGE TREE FARM, INC. ("CORPORATION"). The street address, along with the mailing address of the principal office of the Corporation, shall be 9101 Fort King Road, Dade City, Fl. 33525-0836

ARTICLE II
TERM

The corporation's existence shall commence upon the date of the filing of these Articles of Incorporation, and shall continue thereafter in perpetuity.

ARTICLE III
PURPOSE

The general purpose for which this corporation shall exist shall be to transact any or all lawful business permitted any corporation under the Florida General Corporation Act.

ARTICLE IV
NUMBER OF AUTHORIZED SHARES

The corporation shall be authorized to issue an aggregate of One Thousand (1000) shares of common voting stock, each such share to have a par value of One Dollar (\$1.00) and all such shares being the same class.

PREEMPTIVE RIGHTS

All of the shareholders of this corporation shall be entitled to the benefits of preemptive rights with respect to any uninsured or treasury shares of ownership of this corporation.

ARTICLE VI
RESIDENT AGENT

The street address of the initial registered office of the corporation shall be 9101 Fort King Road, Dade City, Fl. 33525-0836, and the initial registered agent for the corporation shall be James E. Rinaldo, whose business address is identical to the address of the registered office of the corporation.

ARTICLE VII
BOARD OF DIRECTORS

Initially, the corporation shall have a Board of Directors consisting of two (2) members whose names and addresses are as follows:


